**ORDER**

The provisional affiliation was granted for starting B.Com Finance programme with an intake of 40 students at College of Applied Science, Vadakkenchery, Palakkad (Self Financing) during the academic year 2017-18 vide U.O. read as 1<sup>st</sup> above.

2. The Principal, College of Applied Science, Vadakkenchery, Palakkad (Self Financing) has requested to grant continuation of provisional affiliation to B.Com Finance programme for the academic year 2018-19 and remitted required fee vide paper read as 2<sup>nd</sup> above.

3. An inspection commission was appointed to consider the continuation of provisional affiliation to the B.Com Finance programme at College of Applied Science, Vadakkenchery, Palakkad during the academic year 2018-19 vide U.O. read as 3<sup>rd</sup> above.

4. The inspection commission, vide paper read as 4<sup>th</sup>, submitted the inspection report and recommended for continuation of provisional affiliation to B.Com Finance programme at College of Applied Science, Vadakkenchery, Palakkad (Self Financing) during the academic year 2018-19.

5. The Principal has remitted an amount of ₹ 7,500/- (Rupees seven thousand and five hundred only) towards the inspection commission fee vide chalan no. 181004083 dated 09.01.2018.

6. Considering the above, the Vice Chancellor has accorded sanction for granting **continuation of provisional affiliation to B.Com Finance programme with an intake of 40 students** at College of Applied Science, Vadakkenchery, Palakkad, (Self Financing), with common courses - English & Hindi/ Malayalam, **during the academic year 2018-19.**

7. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has

to apply for continuation of provisional affiliation for the ensuing years by remitting the fee fixed by the University.

8. Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University/Government from time to time, failing which the affiliation granted will automatically be cancelled.

9. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.

10. The complementary courses / common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject / for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University. The Principal shall strictly follow the approved syllabi, which is available in the University website ([www.universityofcalicut.info](http://www.universityofcalicut.info)) for selecting the complementary courses.

11. The list of colleges which have renewed their provisional affiliation or applied for continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for continuation of provisional affiliation.

12. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including the withdrawal of affiliation of the college will be initiated.
