ORDER

As per the paper read as 1st above, Principal, College of Applied Science, Vadakkencherry, Palakkad has submitted an application for starting new self-financing programme viz. B.Com (Finance) for the academic year 2016-17 and 2017-18.

2. The District Level Inspection Commission, vide paper read as 2nd above, conducted the inspection at the College and recommended for starting B.Com (Finance) programme with an intake of 40 students for the academic year 2016-17 and 2017-18 and subsequently the same has been recommended to the Govt. for concurrence vide reference cited 3rd above.

3. The Government of Kerala has issued sanction for starting a new programme viz- B.Com (Finance) with an intake of 40 students in the College of Applied Science, Vadakkencherry , Palakkad for the academic year 2017-18 vide G.O. read as 4th above.

4. The Principal, College of Applied Science, Vadakkencherry, Palakkad vide paper read as 5th above, has requested to grant Provisional Affiliation for starting new programme viz. B.Com (Finance) with an intake of 40 students for the academic year 2017-18. The college has remitted an amount of Rs. 10,000/- (Rupees Ten Thousand only) towards the affiliation fee for the above programme vide Chalan No. 171278892 dated 25.04.2017. The Principal has also submitted the a notarised undertaking in stamp paper worth Rs. 200/- duly signed by the Principal and Director of College of Applied Science, Vadakkencherry, Palakkad (Managed by IHRD, A Govt. of Kerala undertaking).

5. Considering the matter in detail, sanction has been accorded by the Hon'ble Vice Chancellor on 17.05.2017 for granting Provisional Affiliation for starting the new programme viz. B.Com (Finance) with an intake of 40 students at College of Applied Science, Vadakkanchery, Palakkad for the academic year 2017-

18 by exercising the powers laid down in Para 13, clause 10, Chapter III of the CU Act 1975, and to report the same to the next Syndicate.

6. Affiliation granted is strictly provisional and only for the academic year 2017-18. The Continuation of Provisional Affiliation for the ensuing years should be obtained after applying for the same along with required fee.

7. Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued from time to time, failing which the affiliation granted will automatically be cancelled. Admission to the next academic year shall be made only after obtaining prior permission from the University.

8. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

9. The list of colleges which have renewed their provisional affiliation or applied for Continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those colleges which have not applied for Continuation of Provisional Affiliation.

10. In the light of the directions of the Supreme Court of India in WP (C)No.656/1998, the institutions shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of affiliation of the college will be initiated.
