Provisional affiliation was granted for starting B.Sc Computer Science and B.Sc. Electronics programmes during the academic year 1993-94, MCA during 2001-02, M.Sc Computer Science during 2002-03, M.Sc Electronics during 2003-04 and B.Com Computer Application during 2009-10 at the College of Applied Science, Vadakkenchery, Palakkad as per the University Orders read as 1st to 5th above.

- 2. The MCA programme was disaffiliated with effect from the academic year 2016-17 vide U.O. read as 6th above. Continuation of provisional affiliation was granted to 1) B.Sc. Electronics 2) B.Com Computer Applications 3) M.Sc Computer Science and 4) M.Sc Electronics programmes at the College of Applied Science, Vadakkenchery, Palakkad for the academic year 2017-18 vide U.O. read as 7th above. A permanent increase of 2 seats was sanctioned to the college for B.Sc Electronics programme during the academic year 2017-18 vide U.O. read as 8th above.
- 3. As per letter read as 9th above, the Principal, College of Applied Science, Vadakkenchery, Palakkad has requested to grant continuation of provisional affiliation to the above programmes for the academic year 2018-19. The College has remitted an amount of Rs. 85,000/- (Rupees eighty five thousand only) as administration & affiliation fee vide Chalan No. 172087126 dated 07.12.2017.
- 4. Sanction has, therefore, been accorded by the Vice Chancellor for granting continuation of provisional affiliation to the following programmes at the College of Applied Science, Vadakkenchery, Palakkad for the academic year 2018-19.

- 5. Affiliation granted is strictly provisional and only for the academic year 2018-19. Continuation of provisional affiliation for the ensuing years should be obtained by applying for the same along with the required fee.
- 6. Selection and admission shall be made only on the basis of the rules and regulations of the University and Government and on the basis of the directions issued from time to time, failing which the affiliation granted will automatically be cancelled.
- 7. Admission to the next academic year shall be made only after obtaining prior permission from the University. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.
- 8. The list of Colleges which have renewed their provisional affiliation or applied for continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to see that examinations are not conducted in those Colleges which have not applied for continuation of provisional affiliation.
- 9. The Principal shall strictly follow the approved syllabus, which is available in the University website (www.universityofcalicut.info), for selecting complementary courses.
- 10. In the light of the directions of the Supreme Court of India in WP(C)No. 656/1998, the institutions shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances appropriate action including withdrawal of Affiliation of the College will be initiated.
