ORDER

Provisional affiliation was granted to start College of Applied Science, Vadakkencherry, Palakkad under IHRD in the academic year 1993-94 with B.Sc Computer Science(24) and B.Sc Electronics (24) programmes, vide University Order read as (1). Later the intake of B.Sc Electronics (24) and B.Sc Computer Science (24) was increased to 34 and 36 respectively. Additional affiliation was granted to M.Sc Computer Science (12) in the academic year 2002-03, M.Sc Electronics (12) in 2003-04 and B.Com Computer Application (40) in 2009-10, vide University Orders read as (2), (3) and (4) respectively.

2. Additional affiliation was granted to B.Com Finance (40) in the academic year 2017-18, vide University Orders read as (5) and (7). Permanent increase in seats was granted to B.Sc Electronics from 34 to 36 w.e.f the academic year 2017-18, vide University Order read as (6). Continuation of provisional affiliation was granted to the aforementioned programmes for the academic year 2023-24, vide University Order read as (8).

3. The Principal, College of Applied Science (Unaided), Vadakkencherry, Palakkad vide paper read as (9) has applied for continuation of provisional affiliation to the existing programmes for the academic year 2024-25 by remitting the required fee.

4. Considering the above, the Vice Chancellor has accorded sanction for granting continuation of provisional affiliation for the academic year 2024-25 to the programmes, as detailed below with strict direction to engage faculties with qualifications prescribed by the respective regulatory body and in compliance with the provisions of the ACT 13 of 2021.

5. Orders are issued accordingly subject to the following terms and conditions :

- Affiliation granted is strictly provisional and only for the academic year 2024-25.
- The Principal shall strictly follow the syllabi available in the University website www.uoc.ac.in for selecting complementary courses.
- The complementary courses/common courses specified in this order are based on the details of registration of candidates for examination and shall not be treated as a factor for calculating the work load for the subject/ for the requirement of teaching faculty, for which competent orders shall be obtained from the Govt/University.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/ Government and on the basis of the directions issued by the University/Government from time to time.
- In the light of the directions of the Supreme Court of India in WP (C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form.
- The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid continuation of provisional affiliation orders.
- The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- Admission to the next academic year shall be made only after obtaining prior permission from the University.
- Violation of any of the above will lead to the cancellation of affiliation.
