ORDER

Provisional affiliation has been granted to start College of Applied Science(self financing), Vadakkencherry, Palakkad under IHRD in the academic year 1993-94 with B.Sc Computer Science(24), B.Sc Electronics(24) and B.Com Computer Application(40) programmes, vide University Order read as first above. Later, the intake of B.Sc Electronics (24) and B.Sc Computer Science (24) has been increased to 34 and 36 respectively.

2. Additional affiliation has been granted to M.Sc Computer Science (12) in the academic year 2002-03, M.Sc Electronics (12) in 2003-04 and B.Com Computer Application (40) in 2009-10, vide University Orders read as second, third and fourth above respectively.

3. Additional affiliation has been granted to B.Com Finance (40) in the academic year 2017-18, vide University Orders read as fifth and sixth above. Permanent increase in seats has been granted to B.Sc Electronics from 34 to 36 w.e.f the academic year 2017-18, vide University Order read as seventh above.

4. Continuation of provisional affiliation has been granted to the aforementioned programmes for the academic year 2019-20, vide University Order read as eighth above.

5. The Principal, College of Applied Science (Unaided), Vadakkencherry, Palakkad as per paper read as ninth above, has applied for continuation of provisional affiliation to the existing programmes for the academic year 2020-21 after remitting the affiliation fee required ₹74815/- (Rupees Seventy four thousand eight hundred and fifteen only) online vide chalan no. 192168866 dated 08.11.2019.

6. After examining the matter in detail, the Vice Chancellor has accorded sanction, as read as tenth above, for continuation of provisional affiliation to the programmes run by College of Applied Science, Vadakkencherry, Palakkad for the academic year 2020-21.

7. Continuation of provisional affiliation for the academic year 2020-21 is, therefore, granted to the following programmes offered by College of Applied Science(Unaided), Vadakkencherry, Palakkad as detailed below, subject to the conditions mentioned herein:

8. Affiliation granted is strictly provisional and only for the academic year 2020-21. The College has to apply for continuation of provisional affiliation for the ensuing academic years by remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.

9. The management should abide by the provisions of the University Act, Statute and Regulations with regard to admission of students, collection of fee etc.

10. Selection and admission shall be made only on the basis of the rules and regulations of the University/ Government and on the basis of the directions issued by the University/ Government from time to time, failing which the affiliation granted will automatically be cancelled.

11. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.

12. The Principal shall strictly follow the syllabi approved, which is available in the University website (www.uoc.ac.in) for selecting complementary courses.

13. The list of colleges which have renewed their provisional affiliation or applied for continuation of provisional affiliation will be forwarded to the office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.

14. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, stringent action including withdrawal of affiliation of the College will be initiated.
